7 **A Resolution authorizing the County Executive to execute a grant agreement with the Ohio**
8 **& Erie Canal Corridor Coalition, Inc. d.b.a. Ohio & Erie Canalway Coalition, for a grant,**
9 **in an amount not to exceed \$35,000.00, for Canal Corridor Development and Trail**
10 **Planning in the form of grants to various communities in partnership with the Coalition,**
11 **for the Executive's Department of Finance and Budget, and declaring an emergency.**

13 WHEREAS, pending before this Council is Resolution No. 2018-058, which adopts the
14 Capital Improvements Program for 2018-2023 for the County of Summit and appropriates funds,
15 in the amount of \$12,633,855.00, for the balance of projects in the 2018 Capital Improvement
16 Plan; and

18 WHEREAS, as part of the 2018 Capital Improvements Program Budget, Resolution No. 2018-
19 058 appropriates funds in Account No. 40010-820501-78501, in the amount of \$35,000.00, for a
20 grant to the Ohio & Erie Canal Corridor Coalition, Inc. d.b.a. Ohio & Erie Canalway Coalition,
21 an Ohio nonprofit corporation (the "Coalition"), for Canal Corridor Development and Trail
22 Planning, which will be in the form of grants to various communities in partnership with the
23 Coalition in 2018; and

25 WHEREAS, the County of Summit is committed to working to preserve and develop the
26 Ohio and Erie Canal National Heritage Corridor; and

28 WHEREAS, the County wishes to provide a grant to the Coalition, in an amount not to
29 exceed \$35,000.00, for Canal Corridor Development and Trail Planning in the form of grants to
30 various communities in partnership with the Coalition in 2018; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
33 that it is necessary and in the best interest of the County of Summit to authorize the County
34 Executive to execute a contract with the Coalition for said grant for the aforementioned reasons;

36 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
37 of Ohio, that:

41 The County Executive is hereby authorized to execute a contract with the Ohio & Erie
42 Canal Corridor Coalition, Inc. d.b.a. Ohio & Erie Canalway Coalition (the "Coalition") for a
43 grant, in an amount not to exceed \$35,000.00, for Canal Corridor Development and Trail
44 Planning in the form of grants to various communities in partnership with the Coalition in 2018.
45 Said grant will be paid out of Capital Improvements Funds, Account No. 40010-820501-78501.

49 This Resolution is hereby declared an emergency in the interest of the health, safety and
50 welfare of the citizens of Summit County, and for the further reason to immediately provide a
51 grant to the Coalition for Canal Corridor Development and Trail Planning in the form of grants
52 to various communities in partnership with the Coalition in 2018.



16 121.22 of the Ohio Revised Code.


