7 **A Resolution confirming an award by the Board of Control of a renewal (first of two) of a**
8 **professional service contract with Akron Legal News, Inc., to provide publication of notices**
9 **of Sheriff sales and other necessary legal notices, with funds being collected up front by the**
10 **Clerk of Courts, for the period 1/1/19 through 12/31/23, for the Executive's Department of**
11 **Law, Insurance and Risk Management, and declaring an emergency.**

13 WHEREAS, the Board of Control at its meeting held February 28, 2018, awarded a
14 renewal (first of two) of a professional service contract with Akron Legal News, Inc., to provide
15 publication of notices of Sheriff sales and other necessary legal notices, with funds being
16 collected up front by the Clerk of Courts, for the period 1/1/19 through 12/31/23; and

18 WHEREAS, the Court of Common Pleas establishes a fee schedule which includes the cost
19 of such notices, which cost is collected by the Clerk of Courts as part of the filing fees in each
20 case where such notice may be necessary; and

22 WHEREAS, the Court of Common Pleas has, by Miscellaneous Order, approved the use
23 of Akron Legal News for the provision of such services; and

25 WHEREAS, the Council finds and determines, after reviewing all pertinent information,
26 that the aforementioned renewal of a professional service contract with Akron Legal News, Inc.,
27 is necessary and in the best interest of the County of Summit; and

29 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State


