7 **A Resolution authorizing the County Executive to execute any documents necessary to**  
8 **accept an award of a Drug Recognition Expert General Grant from the Ohio Department**  
9 **of Public Safety, for the period 1/1/18 to 9/30/18, in the amount of \$36,455.06 with no local**  
10 **cash match requirement, and appropriating said grant funds, for the Sheriff, and declaring**  
11 **an emergency.**

13 WHEREAS, the County of Summit Sheriff's Office has been awarded a grant, in the  
14 amount of \$36,455.06, with no local cash match requirement, from the Ohio Department of  
15 Public Safety ("ODPS"), through their Ohio Traffic Safety Office ("OTSO"), in order to operate  
16 a Drug Recognition Expert ("DRE") General Grant program in the County of Summit; and

17  
18 WHEREAS, the DRE General grant is a new grant this year that will fund a Drug  
19 Recognition Expert to review all drug evaluations in their region, between January and  
20 September 30, 2018; and

22 WHEREAS, each DRE regional Coordinator will review and approve all drug  
23 evaluations, schedule and teach two (2) Advanced Roadside Impaired Driving Enforcement  
24 ("ARIDE") classes, and develop and teach one (1) DRE recertification class, in their respective  
25 regions in the County of Summit; and

27 WHEREAS, this Council has determined by reviewing all pertinent information that it is  
28 necessary to authorize the County Executive to execute any documents necessary to accept the  
29 aforementioned DRE General Grant through OTSO, and to appropriate said grant funds for the  
30 period 1/1/18 through 12/31/18;

32 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
33 of Ohio, that:
