7 **An Ordinance amending Chapter 143 of the Codified Ordinances of the County of Summit,**
8 **now entitled “Community Development Block Grant Review Committee,” for the**
9 **Executive’s Department of Community and Economic Development, and declaring an**
10 **emergency.**

12 WHEREAS, from time to time, this Council amends the Codified Ordinances of the
13 County of Summit in order to update the same to reflect actual or desired practice of the County;
14 and

16 WHEREAS, the County Executive has proposed amending Chapter 143, now entitled
17 “Community Development Block Grant Review Committee,” to reflect current County practice
18 and current federal regulations regarding the distribution of Community Development Block
19 Grant funds that the County received from the U.S. Department of Housing and Urban
20 Development; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that it is necessary and in the best interest of the County to amend Chapter 143 as proposed by
24 the County Executive;

26 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
27 State of Ohio, that:

29 SECTION 1

31 Chapter 143 of the Codified Ordinances of the County of Summit, now entitled
32 “Community Development Block Grant Review Committee,” is hereby amended as set forth in
33 the attached Exhibit A, which is hereby incorporated as if fully written herein.

37 This Ordinance is hereby declared an emergency in the interest of the health, safety and
38 welfare of the citizens of the County of Summit, and for the further reason to immediately amend
39 Chapter 143 to provide reflect current County practice and federal regulations as soon as
40 practical.

44 Provided this Ordinance receives the affirmative vote of eight members, it shall take
45 effect immediately upon its adoption and approval by the Executive; otherwise it shall take effect
46 and be in force at the earliest time provided by law.

10 the Ohio Revised Code.


