7 **A Resolution confirming an award by the Board of Control of a construction contract with**
8 **Pavement Technology, Inc., for the 2018 Summit County Asphalt Rejuvenating Program,**
9 **in an amount not to exceed \$120,333.73, for the Engineer, and declaring an emergency.**

11 WHEREAS, the Board of Control, at its meeting held May 2, 2018, awarded a
12 construction contract with Pavement Technology, Inc., for the 2018 Summit County Asphalt
13 Rejuvenating Program, in an amount not to exceed \$120,333.73, subject to confirmation by
14 County Council; and

16 WHEREAS, Council finds and determines, after reviewing all pertinent information, that
17 the aforementioned construction contract with Pavement Technology Inc. is necessary and in the
18 best interest of the County of Summit;

20 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
21 of Ohio, that:

23 SECTION 1

25 The award by the Board of Control of a construction contract with Pavement Technology,
26 Inc., for the 2018 Asphalt Rejuvenating Program, in a total amount not to exceed \$120,333.73, is
27 hereby confirmed and the County Executive is hereby authorized to execute such construction
28 contract.

30 SECTION 2

32 This Resolution is hereby declared an emergency in the interest of the health, safety and
33 welfare of the residents of the County of Summit, and for the further reason to immediately
34 provide for a necessary construction contract for the Asphalt Rejuvenating Program in 2018 in
35 order for it to proceed as expeditiously as possible.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.

45 It is found and determined that all formal actions of this Council concerning and relating
46 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
47 deliberations of this Council and of any of its committees that resulted in such formal action,

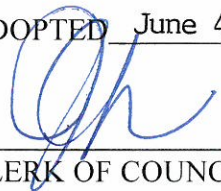
