14 Common Pleas-General Division to fund the redesign of the Court's website, for the period
15 5/1/18 through 4/30/19, in the amount of \$30,109.40, with no local cash match requirement; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that it is necessary and in the best interest of the County of Summit to authorize the County
19 Executive to execute any documents necessary to accept the award of the aforementioned grant
20 from the Ohio Supreme Court and to appropriate said grant funds;


