7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **Schindler Elevator, for a five-year full elevator maintenance service agreement, for the**  
9 **period of 7/1/18 to 6/30/23, at the Summit County Parking Deck and Summit Center**  
10 **Building, in Council District 4, in an amount not to exceed \$81,000.00, for the Executive's**  
11 **Department of Administrative Services-Physical Plants, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held May 9, 2018, awarded a five-year  
14 construction contract with Schindler Elevator, for the period of 7/1/18 to 6/30/23, for full  
15 elevator maintenance service at the Summit County Parking Deck and Summit Center Building,  
16 in Council District 4, in an amount not to exceed \$81,000.00, subject to confirmation by County  
17 Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
20 that the aforementioned construction contract with Schindler Elevator is necessary and in the  
21 best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

26 SECTION 1

28 The award by the Board of Control of a five-year construction contract with Schindler  
29 Elevator, for the period of 7/1/18 to 6/30/23, for full elevator maintenance service at the Summit  
30 County Parking Deck and Summit Center Building, in Council District 4, in an amount not to  
31 exceed \$81,000.00, is hereby confirmed and the County Executive is hereby authorized to  
32 execute such construction contract and any necessary related documents.

36 This Resolution is hereby declared an emergency in the interest of the health, safety and  
37 welfare of the residents of the County of Summit, and for the further reason to immediately  
38 confirm the award of the aforementioned construction contract in order to immediately begin  
39 necessary elevator maintenance.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.
