7 **A Resolution authorizing the County Executive to execute an agreement with the City of**  
8 **Akron for direct indictment services to be provided by the County Prosecutor, and**  
9 **authorizing the appropriation of funds received pursuant to the agreement with the City**  
10 **of Akron for direct indictment services, in the amount of \$310,000.00, for the Prosecutor,**  
11 **and declaring an emergency.**

13 WHEREAS, the County and the City of Akron wish to enter into an agreement for direct  
14 indictment services to be provided by the County Prosecutor, for a one-year term, from 1/1/18  
15 through 12/31/18, or a total cost to the City of Akron not to exceed \$310,000.00; and

16  
17 WHEREAS, it is necessary to authorize the County Executive to execute the  
18 aforementioned agreement with the City of Akron, and to appropriate funds received from the  
19 City of Akron pursuant to said agreement, in the amount of \$310,000.00; and

21 WHEREAS, this Council finds and determines, after reviewing all of the pertinent  
22 information, that it is necessary, and in the best interest of this County, to authorize the County  
23 Executive to execute the aforementioned agreement with the City of Akron for direct indictment  
24 services, and to appropriate funds, in the amount of \$310,000.00, received pursuant to said  
25 agreement, for the provision of direct indictment services;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit,  
28 State of Ohio, that:

32 The County Executive is hereby authorized to execute an agreement with the City of  
33 Akron for direct indictment services to be provided by the County Prosecutor, for a term of one-  
34 year, from 1/1/18 through 12/31/18, with a total cost to the City of Akron not to exceed  
35 \$310,000.00.



29 Section 121.22 of the Ohio Revised Code.


