7 **A Resolution amending the 2018 Staffing Report to add one additional unclassified Senior**
8 **Administrator who will act as the Consolidated Computer Aided Dispatch System**
9 **Administrator, for the Executive, and declaring an emergency.**

11 WHEREAS, Section 169.04(h) of the Codified Ordinances of the County of Summit
12 requires the County Executive to submit annually a report on staffing which sets forth the
13 number of full-time, part-time and seasonal positions within each job classification, that an
14 office, department, agency, board or commission may employ during the following calendar
15 year; and

16
17 WHEREAS, this Council previously adopted Resolution No. 2017-503, which approved
18 and adopted the Report on Staffing for calendar year 2018; and

19
20 WHEREAS, Council recently adopted Resolution No. 2018-208, which authorizes the
21 County Executive to execute an Intergovernmental Agreement for the Acquisition, Installation
22 and Operation of a Consolidated Computer Aided Dispatch System with the City of Akron, City
23 of Cuyahoga Falls, City of Fairlawn, City of Green and City of Stow (the "Agreement"), and
24 appropriates funds necessary for the performance of said Agreement; and

26 WHEREAS, Section 6 of the Agreement requires that the County appoint a Consolidated
27 CAD System Administrator who is the individual employed by the County who is primarily
28 responsible for the management, operation and maintenance of the Consolidated Computer
29 Aided Dispatch System under that section; and

31 WHEREAS, it is necessary to amend the 2018 Staffing Report to add an additional
32 unclassified Senior Administrator position to act as the Consolidated CAD System
33 Administrator; and

35 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
36 that it is necessary and in the best interest of the County of Summit to amend the 2018 Staffing
37 Report to add one additional Senior Administrator who will act as the Consolidated Computer
38 Aided Dispatch System Administrator; and

40 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,
41 State of Ohio, that:

7 safety, and welfare of the citizens of the County of Summit, and for the further reason of
8 immediately amending the 2018 Staffing Report to add one additional unclassified Senior
9 Administrator so that the County can appoint a Consolidated CAD System Administrator upon
10 7/1/18, the effective date of the Intergovernmental Agreement for the Acquisition, Installation
11 and Operation of a Consolidated CAD System.

15 Provided this Resolution receives the affirmative vote of eight members, it shall take
16 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
17 effect and be in force at the earliest time provided by law.
