7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the County of Summit Alcohol, Drug Addiction and Mental Health Services Board**
9 **(“ADM”) to accept a Specialized Docket Subsidy, for the period 7/1/18 through 6/30/19, in**
10 **the amount of \$120,000.00, with no local cash match requirement, for the Court of**
11 **Common Pleas-Juvenile Division, and declaring an emergency.**

13 WHEREAS, the Ohio Department of Mental Health and Addiction Services
14 (“ODMHAS”) has allocated specialized docket subsidies to the County of Summit Alcohol,
15 Drug Addiction and Mental Health Services Board (“ADM”) to assist drug courts and other
16 specialized dockets with funding to effectively manage addicted offenders in the community; and

18 WHEREAS, it is necessary to authorize the County Executive to execute any documents
19 necessary to accept the specialized docket subsidy from ADM to the Court of Common Pleas-
20 Juvenile Division for the period 7/1/18 through 6/30/19, in the amount of \$120,000.00, with no
21 local cash match requirement; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the aforementioned grant funds from ADM;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is hereby authorized to execute an intergovernmental agreement
33 with the County of Summit Alcohol, Drug Addiction Mental Health Services Board to accept a
34 Specialized Docket Subsidy, for the period 7/1/18 through 6/30/19, in the amount of
35 \$120,000.00.

39 This Resolution is declared an emergency in the interest of the health, safety and welfare
40 of the residents of the County of Summit and for the further purpose of immediately authorizing
41 the Executive to execute any documents necessary to accept the Specialized Docket subsidy
42 grant from the ADM Board.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.




