7 **A Resolution confirming the award by the Board of Control of Change Order No. 1 to a**
8 **professional service contract with the County of Summit Developmental Disabilities Board,**
9 **for the period 5/1/18 through 9/30/18, to provide summer youth employment program**
10 **monitoring services, in an amount not to exceed \$80,000.00 (for a cumulative increase of**
11 **57.14%), for a total amount not to exceed \$220,000.00, for the Executive's Department of**
12 **Job and Family Services, and declaring an emergency.**

14 WHEREAS, County Council previously adopted Resolution 2018-157, which authorized
15 the County Executive to execute agreements for Summer Youth Employment Program ("SYEP")
16 Monitoring Services with the County of Summit Developmental Disabilities Board, to provide
17 monitoring services, work readiness skills training, and other additional services, for the period
18 5/1/18 through 9/30/18, in an amount not to exceed \$140,000.00; and

20 WHEREAS, the Board of Control, at its meeting on August 1, 2018, awarded Change
21 Order No. 1 to the County of Summit Developmental Disabilities Board, to provide additional
22 SYEP monitoring services, in an amount not to exceed \$80,000.00 (for a cumulative increase of
23 57.14%), for a total amount not to exceed \$220,000.00, subject to confirmation by County
24 Council; and

26 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
27 that it is necessary and in the best interest of the County of Summit to confirm the award by the
28 Board of Control of Change Order No. 1 to a professional service contract with the County of
29 Summit Developmental Disabilities Board, for the period 5/1/18 through 9/30/18, to provide
30 additional SYEP monitoring services, in an amount not to exceed \$80,000.00 (for a cumulative
31 increase of 57.14%), for a total amount not to exceed \$220,000.00, for the aforementioned
32 reason;

42 in an amount not to exceed \$80,000.00 (for a cumulative increase of 57.14%), for a total amount
43 not to exceed \$220,000.00, is hereby confirmed and the Executive is hereby authorized to
44 execute said Change Order No. 1 and any necessary related documents.
