8 **A Resolution authorizing the County Executive to execute any documents necessary to**
9 **accept an award from the National Council on Aging of a grant, for the period 7/15/18**
10 **through 4/30/20, in the amount of \$75,000, with no local cash match requirement, and**
11 **appropriating funds, for the Executive's Department of Job and Family Services, and**
12 **declaring an emergency.**

14 WHEREAS, the County Executive's Department of Job and Family Services
15 ("SCDJFS") has received notification of an award from the National Council on Aging
16 ("NCOA") of an award of grant funds in the amount of \$75,000.00, with no local cash match
17 requirement; and

18
19 WHEREAS, these funds will enable SCDJFS to increase senior SNAP ("Supplemental
20 Nutrition Assistance Program") enrollment by conducting outreach to low-income seniors in
21 collaboration with the Akron-Canton Regional Food Bank, Mature Services, the Akron
22 Metropolitan Housing Authority and Alpha Phi Alpha Homes; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
26 execute any documents necessary to accept the award from of the aforementioned NCOA grant
27 and to appropriate said grant funds for the period ending 4/30/20;

29 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
30 of Ohio, that:

34 The County Executive is hereby authorized to execute any documents necessary to accept
35 an award from the National Council on Aging ("NCOA") of a grant to the Executive's
36 Department of Job and Family Services, for the period 7/15/18 through 4/30/20, in the amount of
37 \$75,000.00, with no local cash match requirement.

19 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
20 effect and be in force at the earliest time provided by law.
