7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **ICOR Technology Inc., for one bomb robot and accessories for the Ashland County Bomb**
9 **Squad, for a total amount not to exceed \$111,065.00, for the Executive's Department of**
10 **Law and Risk Management-Division of Public Safety, and declaring an emergency.**

12 WHEREAS, this Council previously adopted Resolution No. 2018-133, which authorized
13 the County Executive to advertise for bids for a bomb robot for the Ashland County Bomb
14 Squad, for an estimated total cost not to exceed \$97,915.00; and

15
16 WHEREAS, the Board of Control, at its meeting held July 18, 2018, awarded a purchase
17 contract with ICOR Technology Inc., for one bomb robot for \$104,950, for the Ashland County
18 Bomb Squad, plus three accessories totaling \$6,115.00 (one hand-held controller for \$1,650.00,
19 one Duke Pro Firing system for \$1,550.00, and one Pan Disrupter for \$2,915.00), for a total
20 amount not to exceed \$111,065.00, subject to confirmation by County Council; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
23 that the aforementioned purchase contract with ICOR Technology Inc. is necessary and in the
24 best interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
27 of Ohio, that:

29 SECTION 1

31 The award by the Board of Control of a purchase contract with ICOR Technology Inc. for
32 one bomb robot for \$104,950, for the Ashland County Bomb Squad, plus three accessories
33 totaling \$6,115.00 (one hand-held controller for \$1,650.00, one Duke Pro Firing system for
34 \$1,550.00, and one Pan Disrupter for \$2,915.00), for a total amount not to exceed \$111,065.00,
35 is hereby confirmed and the County Executive is hereby authorized to execute such purchase
36 contract.

40 This Resolution is hereby declared an emergency in the interest of health, safety and
41 welfare of the residents of the County of Summit, and for the further reason to immediately
42 provide necessary equipment for the Ashland County Bomb Squad, and to ensure that grant
43 funds are expended in a timely manner.

47 Provided this Resolution receives the affirmative vote of eight members, it shall take
48 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
49 effect and be in force at the earliest time provided by law.
