7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Summit County Alcohol, Drug Addiction, and Mental Health**
9 **Services Board of a juvenile detention behavioral health services grant, for the period of**
10 **7/1/18 through 6/30/19, in the amount of \$245,346.00, with no local cash match**
11 **requirement, and appropriating said grant funds, for the Court of Common Pleas-Juvenile**
12 **Division, and declaring an emergency.**

14 WHEREAS, the Court of Common Pleas-Juvenile Division has been awarded a juvenile
15 detention behavioral health services grant from the Summit County Alcohol, Drug Addiction,
16 and Mental Health Services Board, for the period 7/1/18 through 6/30/19, in the amount of
17 \$245,346.00, with no local cash match requirement; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that it is necessary and in the best interest of the County of Summit to authorize the County
21 Executive to execute any documents necessary to accept the award of the aforementioned grant
22 from the Summit County Alcohol, Drug Addiction, and Mental Health Services Board and to
23 appropriate said grant funds;

25 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The County Executive is hereby authorized to execute any documents necessary to accept
31 an award from the Summit County Alcohol, Drug Addiction, and Mental Health Services Board
32 of a juvenile detention behavioral health services grant, for the period of 7/1/18 through 6/30/19,
33 in the amount of \$245,346.00, with no local cash match requirement.




