7 **A Resolution confirming an award by the Board of Control of a renewal (fourth and final)**  
8 **of a purchase contract with Metro Regional Transit Authority, as a Best Practical Source,**  
9 **to provide transportation to employment and training related activities for work mandated**  
10 **recipients for the period 10/1/18 through 9/30/19, in an amount not to exceed \$125,000.00,**  
11 **for the Executive's Department of Job and Family Services, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 1, 2018, awarded a renewal  
14 (fourth and final) of a purchase contract with Metro Regional Transit Authority, as a Best  
15 Practical Source, to provide transportation to employment and training related activities for work  
16 mandated recipients, for the period 10/1/18 to 9/30/19, in an amount not to exceed \$125,000.00,  
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information  
20 that the aforementioned renewal of said professional service contract with Metro Regional  
21 Transit Authority is necessary and in the best interest of the County of Summit;

23 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
24 of Ohio, that:

28 The award by the Board of Control of a renewal (fourth and final) of a purchase contract  
29 with Metro Regional Transit Authority, as a Best Practical Source, to provide transportation  
30 services to employment and training related activities and for work mandated recipients, for the  
31 period 10/1/18 to 9/30/19, in an amount not to exceed \$125,000.00, is hereby confirmed and the  
32 County Executive is hereby authorized to execute such renewal of said purchase contract and any  
33 necessary related documents.

37 This Resolution is hereby declared an emergency in the interest of the health, safety and  
38 welfare of the residents of the County of Summit, and for the further reason to immediately  
39 provide for transportation services effective 10/1/18.

43 Provided this Resolution receives the affirmative vote of eight members, it shall take  
44 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
45 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


