7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Rolta AdvizeX Technologies, LLC, at less than State Term pricing, for additional servers**
9 **and storage capacity at the Ohio Means Jobs Center, in an amount not to exceed**
10 **\$35,339.93.00, for the Executive's Department of Job and Family Services and Office of**
11 **Information Technology, and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held August 15, 2018, awarded a
14 purchase contract with Rolta AdvizeX Technologies, LLC, at less than State Term pricing, for
15 additional servers and storage capacity at the Ohio Means Jobs Center, in an amount not to
16 exceed \$35,339.93.00, subject to confirmation by County Council; and

18 WHEREAS, Section 177.13 of the Codified Ordinances of the County of Summit
19 requires that purchases by an officeholder exceeding \$50,000.00 in the aggregate in any calendar
20 year, where no additional competitive quotes or bids have been taken, shall be made only upon
21 authorization of County Council; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that the aforementioned purchase contract with Rolta AdvizeX Technologies, LLC, is necessary
25 and in the best interest of the County of Summit;

27 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
28 of Ohio, that:

32 The award by the Board of Control of a purchase contract with Rolta AdvizeX
33 Technologies, LLC, at less than State Term pricing, for additional servers and storage capacity at
34 the Ohio Means Jobs Center, in an amount not to exceed \$35,339.93.00, is hereby confirmed and
35 the County Executive is hereby authorized to execute such purchase contract and any necessary
36 related documents.

40 This Resolution is hereby declared an emergency in the interest of health, safety and
41 welfare of the citizens of the County of Summit, and for the further reason to immediately
42 provide for necessary equipment to be installed as expeditiously as possible.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
48 effect and be in force at the earliest time provided by law.
