7 **A Resolution certifying delinquent sewer service charges to the Fiscal Officer, for the**  
8 **Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

9  
10 WHEREAS, the billing records at the County Executive's Department of Sanitary Sewer  
11 Services show delinquent sewer service accounts which represent unpaid charges for the past  
12 year; and

13  
14 WHEREAS, Section 6103.02 and 6117.02 of the Ohio Revised Code provide that these  
15 charges are to be certified to the County Fiscal Officer and placed on the property tax duplicate  
16 for collection; and

17  
18 WHEREAS, this Council has determined by reviewing all pertinent information that  
19 certifying the aforementioned charges to the Fiscal Officer is necessary and in the best interest of  
20 County of Summit;

22 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
23 of Ohio, that:

25 SECTION 1

26  
27 The delinquent sewage treatment accounts and delinquent plant operation and pump  
28 station accounts listed in Exhibit A are hereby certified to the County Fiscal Officer in the  
29 amounts stated in the "Balance" column in Exhibit A, to be placed on the tax list and duplicate  
30 on their respective parcels for collection as other taxes are collected.

32 SECTION 2

33  
34 The Clerk of Council shall deliver a copy of this Resolution to the Fiscal Officer who  
35 shall record the delinquent sewer service charges for collection pursuant to state law.

37 SECTION 3

38  
39 This Resolution is hereby declared an emergency in the interest of the health, safety and  
40 welfare of the residents of the County of Summit, and for the further reason to immediately  
41 ensure the certification of charges to the Fiscal Officer.

43 SECTION 4

44  
45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


