11 WHEREAS, the Board of Control, at its meeting held September 5, 2018, awarded a
12 purchase order with the City of Hudson to purchase 1,822.17 tons of road salt, under CUE
13 pricing, in an amount not to exceed \$88,320.58, subject to confirmation by County Council; and,

15 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
16 that the aforementioned purchase order is necessary and in the best interest of the County of
17 Summit;

19 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
20 of Ohio, that:

24 The award by the Board of Control of a purchase order with the City of Hudson to
25 purchase 1,822.17 tons of road salt, under CUE pricing, in an amount not to exceed \$88,320.58,
26 is hereby confirmed and the County Executive is hereby authorized to execute such purchase
27 order.

31 This Resolution is hereby declared an emergency in the interest of the health, safety and
32 welfare of the residents of the County of Summit, and for the further reason to immediately
33 prepare for the 2018-2019 snow and ice season.

37 Provided this Resolution receives the affirmative vote of eight members, it shall take
38 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
39 effect and be in force at the earliest time provided by law.

44 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
