7 **A Resolution confirming an award by the Board of Control of an intergovernmental**
8 **agreement with the Summit County Combined General Health District dba Summit**
9 **County Public Health for Title XX/TANF services to increase utilization of Healthchek**
10 **Early, Periodic, Screening, Diagnostic and Testing for young children, for a one-year term,**
11 **from 10/1/18 to 9/30/19, in an amount not to exceed \$120,000.00, for the Executive's**
12 **Department of Job and Family Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting on September 5, 2018, awarded an
15 intergovernmental agreement with the Summit County Combined General Health District dba
16 Summit County Public Health for Title XX/TANF services to increase utilization of Healthchek
17 Early, Periodic, Screening, Diagnostic and Testing for young children, for a one-year term, from
18 10/1/18 to 9/30/19, in an amount not to exceed \$120,000.00; and

20 WHEREAS, this Council finds and determines after reviewing all pertinent information,
21 that the aforementioned intergovernmental agreement with the Summit County Public Health is
22 necessary and in the best interest of the County of Summit;

29 The award by the Board of Control of an intergovernmental agreement with the Summit
30 County Combined General Health District dba Summit County Public Health for Title
31 XX/TANF services to increase utilization of Healthchek Early, Periodic, Screening, Diagnostic
32 and Testing for young children, for a one-year term, from 10/1/18 to 9/30/19, in an amount not to
33 exceed \$120,000.00 is hereby confirmed and the County Executive is hereby authorized to
34 execute such intergovernmental agreement.

39 welfare of the residents of the County of Summit and for the further purpose of immediately
40 providing necessary services for the Executive's Department of Job and Family Services
