Summit County Combined General Health District dba Summit County Public Health (SCPH)	<p><b>Adult Protective Services (APS) nurse and sanitarian services:</b> DJFS APS assists vulnerable elderly adults in need of protection to prevent abuse, neglect or exploitation. These services are provided through a community response model, with DJFS directing an interdisciplinary team of community providers, to coordinate services for a safety net of care management. This model increases client access to critical services and provides ongoing supportive care management to establish and ensure continued client safety. <b>Under this agreement SCPH will provide</b> nurse and sanitarian services in cases involving medical risks or housing issues such as infestation or hoarding. Services will include home visits and follow-up support to assist in the development and implementation of protective plans. Nursing staff will be located at DJFS and will attend case review meetings.</p>	Board of Control Directive 269-17 and County Council Resolution No. 2017-383	\$259,000.00
Battered Women's Shelter of Summit and Medina Counties (BWS)	<p><b>Adult Protective Services (APS) social worker, after hours call response, emergency shelter and triage/stability team services:</b> Social worker services will be provided by a worker located at DJFS and will include case management, resource acquisition, consultation with APS Investigators and home visits. After hour APS call response will include weekday evening services (4:00 p.m. until 8:00 a.m.) and 24 hour call response on weekends and holidays. Shelter services will be provided for referred APS clients in need of emergency housing for various reasons, such as dangerous situations, evictions, deplorable living conditions or homeless.</p> <p>APS triage/stability team services will provide immediate crisis intervention, specialized follow-up services, and ongoing monitoring to seniors in emergency living situations in order to ensure their health, safety and well-being and prevent recidivism. Services will include around the clock in-field crisis intervention, safety planning and, when applicable, emergency shelter in suites dedicated to APS seniors at the BWS facility. Additionally, the triage/stability team will conduct timely welfare checks for vulnerable seniors whose cases have been completed to prevent recurring abuse, neglect or exploitation.</p>	Board of Control Directive 265-17 and County Council Resolution No. 2017-386	\$330,000.00
Vantage Aging	<p><b>Adult Protective Services (APS) liaison services:</b> This agreement provides liaison services between Vantage Aging and DJFS APS to ensure continuity of care for at risk adults through service coordination and individualized client plans which include the following: Workforce Solutions, Meals on Wheels, Behavioral Health Solutions and Home Wellness Solutions. Services also include establishing and maintaining case records and data reports, assisting the APS team in decision making to determine the least restrictive environment for clients and court testimony as needed for protective/restraining orders and guardianship.</p>	n/a	\$60,000.00
