7 **A Resolution confirming an award by the Board of Control of a professional service**
8 **contract with United Way of Summit County, as Best Practical Source, to provide 2-1-1**
9 **information and referral services to assist low income families in accessing non-profit and**
10 **government services to meet basic needs, for the period 10/1/18 through 9/30/19, in an**
11 **amount not to exceed \$100,000.00, for the Executive's Department of Job and Family**
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held September 5, 2018, awarded a
15 professional service contract with United Way of Summit County, as Best Practical Source, to
16 provide 2-1-1 information and referral services to assist low income families in accessing non-
17 profit and government services to meet basic needs, for the period 10/1/18 through 9/30/19, in an
18 amount not to exceed \$100,000.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information
21 that the aforementioned professional service contract with United Way of Summit County is
22 necessary and in the best interest of the County of Summit;

24 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

29 The award by the Board of Control of a professional service contract with United Way of
30 Summit County as Best Practical Source, to provide 2-1-1 information and referral services to
31 assist low income families in accessing non-profit and government services to meet basic needs,
32 for the period 10/1/18 through 9/30/19, in an amount not to exceed \$100,000.00, is hereby
33 confirmed and the County Executive is hereby authorized to execute such professional service
34 contract.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents of the County of Summit, and for the further reason to immediately
40 provide 2-1-1 information and referral services to assist low income families effective 10/1/18.

45 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
46 effect and be in force at the earliest time provided by law.
