7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with Motorola Solutions, to provide support services for a NICE phone logging**  
9 **system for the period of 8/1/18 through 7/31/21, in an amount not to exceed \$87,258.00, and**  
10 **appropriating funds in the amount of \$87,258.00, for the Executive's Department of Law**  
11 **and Risk Management–Division of Public Safety and declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held September 19, 2018, awarded a  
14 professional service contract with Motorola Solutions to provide support services for a NICE  
15 phone logging system for the period of 8/1/18 through 7/31/21, in an amount not to exceed  
16 \$87,258.00, subject to confirmation by County Council; and

18 WHEREAS, funds need to be appropriated in order to support a NICE phone logging  
19 system for the 800MHz Regional Radio System; and

21 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
22 that the aforementioned professional service contract with Motorola Solutions is necessary and in  
23 the best interest of the County of Summit;

25 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

30 The award by the Board of Control of a professional service contract with Motorola

16 121.22 of the Ohio Revised Code.


