7 **A Resolution confirming an award by the Board of Control of a renewal (first of two), of a**
8 **professional service contract with Oriana House, Inc. to provide treatment and program**
9 **services under the Fiscal Year 2017 Multi-Jurisdictional Drug Court program for the**
10 **project period of 9/30/18 through 9/29/19, in an amount not to exceed \$323,700.00, for the**
11 **Executive’s Department of Law and Risk Management–Division of Public Safety and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held September 19, 2018, awarded a
15 first renewal (first of two), of a professional service contract with Oriana House, Inc. to provide
16 treatment and program services under the Fiscal Year 2017 Multi-Jurisdictional Drug Court
17 program for the project period of 9/30/18 through 9/29/19, in an amount not to exceed
18 \$323,700.00, subject to confirmation by County Council; and

20 WHEREAS, the Substance Abuse and Mental Health Administration (“SAMHSA”) has
21 awarded grant funds for the second of three project periods, for the Fiscal Year 2017 Multi-
22 Jurisdictional Drug Court program, from 9/30/18 through 9/29/19; and

24 WHEREAS, this Council previously adopted Resolution No. 2017-406 authorizing the
25 Executive to execute an agreement with Oriana House, Inc. to provide treatment and services for
26 the Multi-Jurisdictional Drug Court program for the project period 9/30/17 through 9/29/18, with
27 two options to renew; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned first renewal of a professional service contract with Oriana House, Inc. is
31 necessary and in the best interest of the County of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

38 The award by the Board of Control of a first renewal (first of two) of a professional
39 service contract with Oriana House, Inc. to provide treatment and program services under the
40 Fiscal Year 2017 Multi-Jurisdictional Drug Court program for the project period of 9/30/18
41 through 9/29/19, in an amount not to exceed \$323,700.00, is hereby confirmed and the County
42 Executive is hereby authorized to execute such professional service contract.

48 provide treatment and program services during the project period of 9/30/18 through 9/29/19.
