12 WHEREAS, County Council previously adopted Resolution 2017-095, which authorized
13 the County Executive to execute any documents necessary to accept a grant from the Safety and
14 Justice Challenge Grant from the MacArthur Foundation, for the period of 1/1/17 through
15 06/30/18, in the amount of \$50,000.00, with no local cash match requirement, and appropriated
16 said grant funds, for the Executive's Department of Law and Risk Management–Division of
17 Public Safety; and

19 WHEREAS, it is necessary to adjust existing appropriations, in the amount of
20 \$15,334.81, from the Salaries and Benefits accounts to the Contract Services account, because of
21 a change in the scope of the project; and

24 that the aforementioned adjustment of appropriations is necessary and in the best interest of the
25 County of Summit;
