TO THE COUNCIL, COUNTY OF SUMMIT, OHIO:

The undersigned hereby petition your honorable body to vacate the public road of Oakdale Street as shown on the attached Plat and described as follows:

Situated in the Township of Northfield Center, County of Summit, and State of Ohio.

- WHEREAS A portion of Oakdale Street is located adjacent to Matthew Reville's residence;
- WHEREAS A portion of Oakdale Street is located adjacent to Richard Reville's property;
- WHEREAS The only purpose of Oakdale Street is to provide access to 8002 Linwood Ave., Northfield Center, Ohio 44067;
- WHEREAS 8002 Linwood Ave., Northfield Center, Ohio 44067 is also accessible from Linwood Avenue;
- WHEREAS Oakdale Street has not been maintained by the Township or County for more than 21 years;
- WHEREAS The petitioners respectfully represent and allege that Oakdale Street is useless as a part of the road system;
- WHEREAS The undersigned desire that Oakdale Street be vacated and requests that the Summit County Council approve the equal distribution.
