7 **A Resolution authorizing the County Executive to advertise for bids for the construction of**
8 **a new lift station and force main for the Aurora Shores Wastewater Treatment Plant**
9 **Abandonment Project (Q-178) in the Village of Reminderville, in Council District 1, for an**
10 **estimated total cost not to exceed \$2,778,000.00, and repealing Resolution No. 2018-194, for**
11 **the Executive's Department of Sanitary Sewer Services, and declaring an emergency.**

13 WHEREAS, it is necessary to construct a new lift station and force main of sufficient
14 capacity to replace the Aurora Shores Wastewater Treatment Plant (WWTP #29) in order to
15 handle anticipated ultimate design average flows from the Village of Reminderville service area,
16 in Council District 1, that will discharge to the Twinsburg sanitary sewer collection system; and

17
18 WHEREAS, the County Executive wishes to advertise for bids for the construction of a
19 new lift station and force main for the Aurora Shores Wastewater Treatment Plant Abandonment
20 Project (Q-178) (“Project”) in the Village of Reminderville, in Council District 1, for an
21 estimated total cost not to exceed \$2,778,000.00; and

23 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
24 requires this Council’s authorization for the County to advertise for bids for construction
25 contracts in excess of \$50,000.00; and

26
27 WHEREAS, a copy of the plans and specifications for the Project are on file with the
28 Clerk of Council; and

29
30 WHEREAS, the Project will be financed through a loan from the Ohio Water
31 Development Authority and repaid through revenue from the County’s sanitary sewer district;
32 and

34 WHEREAS, it is necessary to repeal Resolution No. 2018-194, which previously
35 authorized the County Executive to advertise for bids for the Project at an estimated cost of
36 \$2,317,000.00, due to the increase in cost of material and equipment; and

38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
39 that it is necessary, and in the best interest of the County to authorize the County Executive to
40 advertise for bids for the construction of the aforementioned Project, for an estimated total cost
41 not to exceed \$2,778,000.00, and to repeal Resolution No. 2018-194;

43 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
44 of Ohio, that:

48 The County Executive is hereby authorized to advertise for bids for the construction of a
49 new lift station and force main for the Aurora Shores Wastewater Treatment Plant Abandonment
50 Project (Q-178) in the Village of Reminderville, in Council District 1, for an estimated total cost
51 not to exceed \$2,778,000.00.

17 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
18 effect and be in force at the earliest time provided by law.

23 to the adoption of the Resolution were adopted in an open meeting of this Council, and that all
24 deliberations of this Council and of any of its committees that resulted in such formal action,

26 121.22 of the Ohio Revised Code.
