7 **A Resolution authorizing the County Executive to execute, pursuant to Section 3133.951 of**
8 **the Ohio Revised Code, a Memorandum of Understanding and a School Resource Officer**
9 **Funding Agreement with the Green Local School District Board of Education for a School**
10 **Resource Officer program, in the City of Green, in Council District 8, for a four Academic**
11 **Year term, in exchange for payment by the Board of a total amount of \$1,913,385.27**
12 **during the four Academic Year terms of the agreement, for the Sheriff, and declaring an**
13 **emergency.**

15 WHEREAS, the Ohio General Assembly recently adopted Substitute House Bill No. 318,
16 enacting Section 3133.951 of the Ohio Revised Code, which authorizes a peace officer who is
17 appointed through a memorandum of understanding between a law enforcement agency and a
18 school district to provide services set forth in that section to a school district or school; and

20 WHEREAS, the County Executive, the County Sheriff and the Green Local School
21 District Board of Education, wish to enter into a Memorandum of Understanding (“MOU”) and a
22 School Resource Officer Funding Agreement (“Funding Agreement”) with the Green Local
23 School District Board of Education for a School Resource Officer program, in the City of Green,
24 in Council District 8, in exchange for payment by the Board of the amount of \$456,894.18 for
25 Academic Year One, the amount of \$471,317.61 for Academic Year Two, the amount of
26 \$485,782.93 for Academic Year Three and the amount of \$499,390.55 for Academic Year Four,
27 for a total amount of \$1,913,385.27 during the four Academic Year term of the MOU and
28 Funding Agreement; and

30 WHEREAS, said MOU and Funding Agreement will set forth the duties and
31 responsibilities of the School Resource Officers and the funding amount to be paid during the
32 terms of the MOU and Funding Agreement; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the County
36 Executive to execute the aforementioned MOU and Funding Agreement with the Green Local
37 School District Board;

39 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
40 of Ohio, that;

44 The County Executive is hereby authorized to execute, pursuant to Section 3133.951 of the
45 Ohio Revised Code, a Memorandum of Understanding (“MOU”) and a School Resource Officer
46 Funding Agreement (“Funding Agreement”) with the Green Local School District Board of
47 Education for a School Resource Officer program, in the City of Green, in Council District 8, in
48 exchange for payment by the Board of the amount of \$456,894.18 for Academic Year One, the
49 amount of \$471,317.61 for Academic Year Two, the amount of \$485,782.93 for Academic Year
50 Three and the amount of \$499,390.55 for Academic Year Four, for a total amount of
51 \$1,913,385.27 during the four Academic Year term of the MOU and Funding Agreement.

6 This Resolution is hereby declared an emergency in the interest of the health, safety and
7 welfare of the residents of the County of Summit and for the further reason to immediately
8 authorize the appointment of School Resource Officers to provide services to the Green Local
9 School District Board of Education, in the City of Green, in Council District 8, as soon as
10 practicable.

14 Provided this Resolution receives the affirmative vote of eight members, it shall take
15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
16 effect and be in force at the earliest time provided by law.

21 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
22 deliberations of this Council and of any of its committees that resulted in such formal action,
