7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Mid-American Salt, LLC, for road salt for the 2018-2019 snow and ice control season,**
9 **under CUE pricing, in an amount not to exceed \$408,000.00, for the Engineer, and**
10 **declaring an emergency.**

12 WHEREAS, the Board of Control, at its meeting held October 24, 2018, awarded a
13 purchase contract to Mid-American Salt, LLC, for road salt for the 2018-2019 snow and ice
14 control season, under CUE pricing, in an amount not to exceed \$408,000.00, subject to
15 confirmation by County Council; and

17 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
18 that the aforementioned purchase contract with Mid-American Salt, LLC is necessary and in the
19 best interest of the County of Summit;

21 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
22 of Ohio, that:

26 The award by the Board of Control of a purchase contract with Mid-American Salt, LLC,
27 for road salt for the 2018-2019 snow and ice control season, under CUE pricing, in an amount
28 not to exceed \$408,000.00, is hereby confirmed and the County Executive is hereby authorized
29 to execute such purchase contract.

31 SECTION 2

33 This Resolution is hereby declared an emergency in the interest of the health, safety and
34 welfare of the residents of Summit County, and for the further reason to immediately provide for
35 road salt for the 2018-2019 snow and ice control season.

39 Provided this Resolution receives the affirmative vote of eight members, it shall take
40 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
41 effect and be in force at the earliest time provided by law.
