7 **A Resolution confirming the award of a professional service contract with CourtView**
8 **Justice Solutions, Inc. dba equivalent, as a Sole Source, for system software, for a five-year**
9 **term, from 1/1/19 through 12/31/23, with one option to renew for an additional five year**
10 **term, in an amount not to exceed \$400,504.00, for the Court of Common Pleas-Probate**
11 **Division, and declaring an emergency.**

13 WHEREAS, Board of Control, at its meeting on October 17, 2018, awarded a
14 professional service contract with CourtView Justice Solutions, Inc. dba equivalent, as a Sole
15 Source, approved by the IT Board on 10/11/18, for system software, which includes case
16 management, financial management, judicial management, eAccess and OnBase imaging and
17 upgrades, for a five-year term, from 1/1/19 through 12/31/23, with one option to renew for an
18 additional five year term, in an amount not to exceed \$400,504.00, subject to confirmation by
19 County Council; and

21 WHEREAS, the cost to the County for the five-year term of the professional service
22 contract will be an amount not to exceed \$72,482.00 for year one, an amount not to exceed
23 \$76,105.00 for year two, an amount not to exceed \$79,910.00 for year three, an amount not to
24 exceed \$83,906.00 for year four and an amount not to exceed \$88,101.00 for year five, for a total
25 cost not to exceed \$400,504.00; and

27 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
28 that the aforementioned professional service contract with CourtView Justice Solutions, Inc. dba
29 equivalent is necessary and in the best interest of the County of Summit;

31 NOW, THEREFORE, BE IT RESOLVED, by the Council of the County of Summit,

36 The award by the Board of Control of a professional service contract with CourtView
37 Justice Solutions, Inc. dba equivalent, as a Sole Source, approved by the IT Board on 10/11/18, for
38 system software, which includes case management, financial management, judicial management,
39 eAccess and OnBase imaging and upgrades, for a five-year term, from 1/1/19 through 12/31/23,
40 with one option to renew for an additional five year term, with four options to renew for an
41 additional one-year term, in an amount not to exceed \$400,504.00, is hereby confirmed and the
42 County Executive is hereby to execute said professional service contract. The total cost of the
43 professional service contract shall be an amount not to exceed \$72,482.00 for year one, an
44 amount not to exceed \$76,105.00 for year two, an amount not to exceed \$79,910.00 for year
45 three, an amount not to exceed \$83,906.00 for year four and an amount not to exceed \$88,101.00
46 for year five, for a total cost not to exceed \$400,504.00.


