7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award by the Public Utilities Commission of Ohio of a 2018 training fund grant,**
9 **for the period 9/27/18 through 9/27/19, in the amount of \$4,768.22, with no local cash match**
10 **requirement, and appropriating funds, for the Executive’s Department of Law and Risk**
11 **Management - Division of Public Safety/Emergency Management Agency, and declaring an**
12 **emergency.**

14 WHEREAS, the Public Utilities Commission of Ohio (“PUCO”) has awarded a PUCO
15 training fund grant to the Summit County Emergency Management Agency (“SCEMA”), for the
16 period 9/27/18 through 9/27/19, in the amount of \$4,768.22 with no local cash match
17 requirement, to provide for SCEMA Special Operations Response Team (“SORT”) trainings;

20 WHEREAS, the funding will provide for a “masters of gas detection” training for fire
21 service personnel; and

23 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 execute any documents necessary to accept the award of the aforementioned training fund grant
26 from the PUCO, and to appropriate these grant funds;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

33 The County Executive is hereby authorized to execute any documents necessary to accept
34 the award of a Public Utilities Commission of Ohio (“PUCO”) training fund grant award from
35 the PUCO, for the period 9/27/18 through 9/27/19, in the amount of \$4,768.22, with no local
36 cash match requirement.
