7 **A Resolution authorizing the County Executive to advertise for bids for mobile and**
8 **portable radios and accessories for various agencies within Ohio Homeland Security**
9 **Region 5, for an estimated total cost not to exceed \$130,000.00, for the Executive's**
10 **Department of Law and Risk Management Division of Public Safety – Emergency**
11 **Management Agency and declaring an emergency.**

13 WHEREAS, Section 177.05 of the Codified Ordinances of the County of Summit
14 requires this Council's authorization for the County Executive to advertise for bids; and

16 WHEREAS, the County Executive wishes to advertise for bids for mobile and portable
17 radios and accessories for various agencies within Ohio Homeland Security Region 5, for an
18 estimated total cost not to exceed \$130,000.00; and

20 WHEREAS, a copy of the bid specifications is on file in the Clerk of Council's office;

23 WHEREAS this Council finds and determines, after reviewing all pertinent information
24 that it is necessary and in the best interest of the County of Summit to authorize the Executive to
25 advertise for bids for the aforementioned radio equipment and accessories;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
28 of Ohio, that:

32 The County Executive is authorized to advertise for mobile and portable radios and
33 accessories for various agencies within Ohio Homeland Security Region 5, for an estimated total
34 cost not to exceed \$130,000.00.

38 This Resolution is hereby declared an emergency in the interest of the health, safety and
39 welfare of the residents of the County of Summit, and for the further reason that it authorizes the
40 Executive to immediately advertise for the aforementioned equipment in order to complete the
41 project within the grant period.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
47 effect and be in force at the earliest time provided by law.


