7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with West, a Thomson Reuters Business, as a Sole Source, for online legal**  
9 **research services for 15 users of Westlaw CLEAR, for a three-year term, with a 3%**  
10 **increase each year, for a total amount not to exceed \$51,283.22, for the Prosecutor, and**  
11 **declaring an emergency.**

13 WHEREAS, the Board of Control, at its meeting held November 28, 2018, awarded a  
14 professional service contract with West, a Thomson Reuters Business, as a Sole Source, for  
15 online legal research services for 15 users of Westlaw CLEAR, for a three-year term, with a 3%  
16 increase each year, for a total amount not to exceed \$33,681.11, subject to confirmation by  
17 County Council; and

19 WHEREAS, the Board of Control will amend its directive to state the correct three-year  
20 total amount of \$51,283.22; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that the aforementioned professional service contract with West, a Thomson Reuters Business, is  
24 necessary and in the best interest of the County of Summit;

26 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State  
27 of Ohio, that:

31 The award by the Board of Control of a professional service contract with West, a  
32 Thomson Reuters Business, as a Sole Source, for online legal research services for 15 users of  
33 Westlaw CLEAR, for a three-year term, with a 3% increase each year, for a total amount not to  
34 exceed \$51,283.22, is hereby confirmed and the County Executive is hereby authorized to  
35 execute such professional service contract.

39 This Resolution is hereby declared an emergency in the interest of health, safety and  
40 welfare of the residents of the County of Summit, and for the further reason to immediately  
41 provide for necessary online legal research services for the Prosecutor.

45 Provided this Resolution receives the affirmative vote of eight members, it shall take  
46 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
47 effect and be in force at the earliest time provided by law.




