7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the City of Twinsburg for the resurfacing of Chamberlin Road, a County highway**
9 **with shared jurisdiction, in Council District 1, with the County contributing funds equal to**
10 **43.81% of the net project costs after application of Summit County Transportation**
11 **Improvement District funds, for an estimated amount of \$289,000.00, for the Engineer, and**
12 **declaring an emergency.**

14 WHEREAS, the City of Twinsburg and the County of Summit have identified the need
15 for the resurfacing of Chamberlin Road, a County highway with shared jurisdiction, in Council
16 District 1;

17
18 WHEREAS, the City of Twinsburg will be bidding and managing the Chamberlin Road
19 Resurfacing Project (hereafter "Project"), and is preparing to move forward with the Project in
20 2019; and

21
22 WHEREAS, the City of Twinsburg will be receiving a grant in the amount of
23 \$140,000.00 from the Summit County Transportation Improvement District that will be applied
24 to the costs of the Project; and

25
26 WHEREAS, the County Engineer and City of Twinsburg desire to enter into an
27 intergovernmental agreement whereby the County will contribute funds equal to 43.81% of the
28 net Project costs after application of the Summit County Transportation Improvement District
29 funds; and

31 WHEREAS, the County's share of the costs of the Project is estimated to be in the
32 amount of \$289,000.00; and

34 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
35 that it is necessary and in the best interest of the County of Summit to authorize the County
36 Executive to execute the aforementioned intergovernmental agreement for the Project; and

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
39 of Ohio, that:

41 SECTION 1

43 The County Executive is hereby authorized to execute an intergovernmental agreement
44 with the City of Twinsburg for the resurfacing of Chamberlin Road, a County highway with
45 shared jurisdiction, in Council District 1, with the County contributing funds equal to 43.81% of
46 the net project costs after application of Summit County Transportation Improvement District
47 funds, for an estimated amount of \$289,000.00, a copy of which is attached hereto as Exhibit A
48 and incorporated fully herein, with such modifications and revisions as shall be in furtherance of
49 the provisions of said intergovernmental agreement and not substantially adverse to the County,
50 all of which shall be conclusively evidenced by the execution thereof by the County Executive.

6 This Resolution is hereby declared an emergency in the interest of the health, safety, and
7 welfare of the residents of Summit County, and for the further reason that it expedites a highway
8 project that promotes safety in the City of Twinsburg in Council District 1.

12 Provided this Resolution receives the affirmative vote of eight members, it shall take
13 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
14 effect and be in force at the earliest time provided by law.

18 It is found and determined that all formal actions of this Council concerning and relating
19 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
20 deliberations of this Council and of any of its committees that resulted in such formal action,
21 were in meetings open to the public, in compliance with all legal requirements, including Section
22 121.22 of the Ohio Revised Code.


