7 **A Resolution authorizing the County Executive to execute, subject to the approval of the**
8 **Board of Control, a professional service contract between the Legal Defenders Office of**
9 **Summit County, Ohio, Inc. and the Summit County Public Defender Commission for legal**
10 **defender services for indigents for the Commission, for the period 1/1/19 to 12/31/19, in an**
11 **amount not to exceed \$619,500.00, for the Executive and the Summit County Public**
12 **Defender Commission, and declaring an emergency.**

13
14 WHEREAS, the County has formed the Summit County Public Defender Commission
15 pursuant to Chapter 120 the Ohio Revised Code; and

16
17 WHEREAS, the Commission is responsible for providing legal defense services to
18 certain indigent persons charged with the commission of crimes under the ORC, the Codified
19 Ordinances of the County of Summit and various municipal ordinances within the boundaries of
20 the County; and

21
22 WHEREAS, the Commission is authorized by Section 120.14 of the Ohio Revised Code
23 to contract with a nonprofit organization to provide legal services to indigent persons; and

25 WHEREAS, the Commission wishes to contract with the Legal Defenders Office of
26 Summit County, Ohio, Inc., a nonprofit corporation, to provide legal representation to indigent
27 persons on behalf of the Commission from 1/1/19 to 12/31/19, for an amount not to exceed
28 \$619,500.00; and

30 WHEREAS, the County Executive is required to execute the aforementioned contract,
31 the cost of which will be paid out of funds appropriated by Council in Account No. 10003-2711-
32 45501 pursuant to Resolution No. 2018-500; and

34 WHEREAS, it is necessary to authorize the County Executive to execute, subject to the
35 approval of the Board of Control, said professional service contract with the Legal Defenders
36 Office of Summit County, Inc. and the Summit County Public Defender Commission for legal
37 defender services for indigents for the Commission, for the period 1/1/19 to 12/31/19, in an
38 amount not to exceed \$619,500.00; and

40 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
41 that it is necessary and in the best interest of the County of Summit to authorize the County
42 Executive to execute, subject to the approval of the Board of Control, the aforementioned
43 professional service contract with the Legal Defenders Office of Summit County, Ohio, Inc.;

45 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

7 Board of Control, a professional service contract between the Legal Defenders Office of Summit
8 County, Ohio, Inc. and the Summit County Public Defender Commission for legal defender
9 services for indigents for the Commission, for the period 1/1/19 to 12/31/19, in an amount not to
10 exceed \$619,500.00.

14 This Resolution is hereby declared an emergency in the interest of the health, safety and
15 welfare of the residents of the County of Summit, and for the further reason to immediately
16 provide necessary legal defender services for indigents in 2019.

18 SECTION 3



30 121.22 of the Ohio Revised Code.


