7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award of a Drug Recognition Expert General Grant from the Ohio Department**
9 **of Public Safety, Ohio Traffic Safety Office, for the period 10/1/18 to 9/30/19, in the amount**
10 **of \$26,516.19 with no local cash match requirement, and appropriating said grant funds,**
11 **for the Sheriff, and declaring an emergency.**

13 WHEREAS, the County Sheriff's Office has been awarded a grant, in the amount of
14 \$26,516.19, with no local cash match requirement, from the Ohio Department of Public Safety,
15 through its Ohio Traffic Safety Office ("OTSO"), for the period 10/1/18 to 9/30/19, in order to
16 operate a Drug Recognition Expert ("DRE") General Grant program in Summit County; and

18 WHEREAS, the DRE regional Coordinator will review and approve all Drug
19 Evaluations, schedule and teach (2) ARIDE classes and develop and teach (1) DRE
20 recertification class in their region, in the County of Summit; and

22 WHEREAS, this Council has determined by reviewing all pertinent information that it is
23 necessary to authorize the County Executive to execute any documents necessary to accept the
24 aforementioned DRE General Grant through OTSO, and to appropriate said grant funds for the
25 period 10/1/18 through 9/30/19;

27 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

32 The County Executive is hereby authorized to execute any documents necessary to accept
33 an award of a grant from the Ohio Department of Public Safety, Ohio Traffic Safety Office, for a
34 Drug Recognition Expert ("DRE") General Grant, for the period of 10/1/18 to 9/30/19, in the
35 amount of \$26,516.19 with no local cash match requirement.
