7 **An Ordinance approving the new Summit County Investment Policy for the County of**  
8 **Summit adopted by the Investment Advisory Board on October 2, 2018, and amending**  
9 **Section 179.05 of the Codified Ordinances of the County of Summit, entitled “Board**  
10 **Investment Policies Adopted,” to incorporate the Investment Policy effective January 1,**  
11 **2019, and make related changes, for the Fiscal Officer, and declaring an emergency.**

13 WHEREAS, the Investment Advisory Board has adopted a new Summit County  
14 Investment Policy, dated October 2, 2018, for the County of Summit, attached hereto as Exhibit  
15 A and incorporated herein as if fully restated, which requires the approval of this Council; and

16  
17 WHEREAS, it is necessary to amend Section 179.05 of the Codified Ordinances of the  
18 County of Summit, entitled “Board Investment Policies Adopted,” to incorporate the new  
19 Summit County Investment Policy effective January 1, 2019, and to make related changes to  
20 Section 179.05; and

22 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
23 that it is necessary and in the best interest of the County of Summit that the new Summit County  
24 Investment Policy adopted by the Board should be approved and that Section 179.05 should be  
25 amended for the aforementioned reason;

27 NOW, THEREFORE, BE IT ORDAINED by the Council of the County of Summit, State  
28 of Ohio, that:

30 SECTION 1

31  
32 The Summit County Investment Policy adopted by the Investment Advisory Board, dated  
33 October 2, 2018, attached hereto as Exhibit A and incorporated herein as if fully restated, is  
34 hereby approved and effective as of January 1, 2019.

36 SECTION 2

37  
38 Section 179.05 of the Codified Ordinances of the County of Summit, entitled “Board  
39 Investment Policies Adopted,” is hereby amended as follows:

41 **“179.05 BOARD INVESTMENT POLICY ADOPTED.**

42 The Summit County Investment Policy adopted by the Investment Advisory Board on  
43 October 2, 2018, effective March 20, 2017, now on file with the Clerk of Council is hereby  
44 adopted and effective as of January 1, 2019 as the uniform policy for investment for the County,  
45 and is further made a part this Chapter as if fully rewritten herein.”

4 SECTION 3

5  
6 This Ordinance is hereby declared an emergency in the interest of the health, safety and  
7 welfare of the residents of the County of Summit and for the further reason that it is necessary to  
8 immediately approve the new Summit County Investment Policy adopted by the Investment  
9 Advisory Board and amend Section 179.05 to incorporate the Investment Policy so that the  
10 County may immediately make investments consistent with the Investment Policy.

12 SECTION 4



15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and be in force at the earliest time provided by law.




