7 **A Resolution confirming an award by the Board of Control of a professional service**  
8 **contract with the Akron Community Service Center & Urban League, Inc. to provide 2019**  
9 **Summer Youth Employment Program eligibility determination, job readiness and**  
10 **employment services for youth ages 14 to 17, for the period 4/1/19 through 9/30/19, in an**  
11 **amount not to exceed \$115,000.00, for the Executive's Department of Job and Family**  
12 **Services, and declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held February 27, 2019, awarded a  
15 professional service contract with the Akron Community Service Center & Urban League, Inc. to  
16 provide 2019 Summer Youth Employment Program eligibility determination, job readiness and  
17 employment services for youth ages 14 to 17, for the period 4/1/19 through 9/30/19, in an  
18 amount not to exceed \$115,000.00, subject to confirmation by County Council; and

20 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
21 that the aforementioned professional service contract with the Akron Community Service Center  
22 & Urban League, Inc. is necessary and in the best interest of the County of Summit;

24 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
25 of Ohio, that:

29 The award by the Board of Control of a professional service contract with the Akron  
30 Community Service Center & Urban League, Inc. to provide 2019 Summer Youth Employment  
31 Program eligibility determination, job readiness and employment services for youth ages 14 to  
32 17, for the period 4/1/19 through 9/30/19, in an amount not to exceed \$115,000.00, is hereby  
33 confirmed and the County Executive is hereby authorized to execute such professional service  
34 contract.

38 This Resolution is hereby declared an emergency in the interest of health, safety and  
39 welfare of the residents of the County of Summit, and for the further reason to immediately  
40 authorize a necessary professional service contract with the Akron Community Service Center &  
41 Urban League, Inc. to provide services for the 2019 Summer Youth Employment Program  
42 effective 4/1/19.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.

10 121.22 of the Ohio Revised Code.


