14 professional service contract with Career Development and Placement Strategies, Inc. for
15 intensive job readiness services to enhance participant personal management skills and establish
16 self-sufficiency, for the period 5/1/19 through 9/30/20, in an amount not to exceed \$200,000.00,
17 subject to confirmation by County Council; and

19 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
20 that the aforementioned professional service contract with Career Development and Placement
21 Strategies, Inc. is necessary and in the best interest of the County of Summit;

32 Executive is hereby authorized to execute such professional service contract.
