7 **A Resolution confirming an award by the Board of Control of a purchase contract with**
8 **Cleveland Freightliner, Inc. for the purchase of one Western Star 4900SF conventional cab**
9 **truck tractor with tandem rear axel, at ODOT pricing, in an amount not to exceed**
10 **\$154,317.00, for the Executive's Department of Sanitary Sewer Services, and declaring an**
11 **emergency.**

13 WHEREAS, the Board of Control, at its meeting held July 24, 2019 awarded a purchase
14 contract to Cleveland Freightliner, Inc. for the purchase of one Western Star 4900SF
15 conventional cab truck tractor with tandem rear axel, at ODOT pricing, in an amount not to
16 exceed \$154,317.00, subject to confirmation by County Council; and

18 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
19 that the aforementioned purchase contract with Cleveland Freightliner, Inc. is necessary and in
20 the best interest of the County of Summit;

22 NOW THEREFORE, BE IT RESOLVED, by the Council of the County of Summit, State
23 of Ohio, that:

25 SECTION 1

27 The award by the Board of Control of a purchase contract to Cleveland Freightliner, Inc.
28 for the purchase of one Western Star 4900SF conventional cab truck tractor with tandem rear
29 axel, at ODOT pricing, in an amount not to exceed \$154,317.00 is hereby confirmed and the
30 County Executive is hereby authorized to execute such purchase contract.

32 SECTION 2

34 This Resolution is hereby declared an emergency in the interest of health, safety and
35 welfare of the residents of the County of Summit, and for the further reason to immediately
36 provide for the aforementioned vehicle for the Executive's Department of Sanitary Sewer
37 Services so that sewer services are not interrupted for customers.

41 Provided this Resolution receives the affirmative vote of eight members, it shall take
42 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take
43 effect and be in force at the earliest time provided by law.

47 It is found and determined that all formal actions of this Council concerning and relating
48 to the adoption of this Resolution were adopted in an open meeting of this Council, and that all
49 deliberations of this Council and of any of its committees that resulted in such formal action,
50 were in meetings open to the public, in compliance with all legal requirements, including Section
51 121.22 of the Ohio Revised Code.




