7 **A Resolution authorizing the County Executive to execute an intergovernmental agreement**
8 **with the City of Akron for the use of the indoor and outdoor firing ranges at the County of**
9 **Summit Sheriff Robert D. Campbell Training Facility, for a one-year term, from 1/1/19**
10 **through 12/31/19, with five options to renew for an additional one-year term, for the**
11 **Sheriff, and declaring an emergency.**

13 WHEREAS, County Council previously adopted Resolution No. 2018-020, which
14 authorized the Executive to execute the renewal (fifth and final) of an intergovernmental
15 agreement with the City of Akron for the use of the indoor and outdoor firing ranges at the
16 County of Summit Sheriff Robert D. Campbell Training Facility, for a one-year term, from
17 1/1/18 through 12/31/18; and

19 WHEREAS, the County and the City of Akron wish to enter into an intergovernmental
20 agreement for the use of the indoor and outdoor firing ranges at the County of Summit Sheriff
21 Robert D. Campbell Training Facility, for a one-year term, from 1/1/19 through 12/31/19, with
22 five options to renew for an additional one-year term; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute said intergovernmental agreement with the City of Akron for the use of use
27 of the indoor and outdoor firing ranges at the County of Summit Sheriff Robert D. Campbell
28 Training Facility for the aforementioned reason;

30 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State
31 of Ohio, that:

33 SECTION 1

35 The County Executive is hereby authorized to execute an intergovernmental agreement
36 with the City of Akron for the use of the indoor and outdoor firing ranges at the County of
37 Summit Sheriff Robert D. Campbell Training Facility, for a one-year term, from 1/1/19 through
38 12/31/19, with five options to renew for an additional one-year term, a copy of which is
39 attached hereto as Exhibit A and incorporated fully herein, with such modifications and revisions
40 as shall be in furtherance of the provisions of said intergovernmental agreement and not
41 substantially adverse to the County, all of which shall be conclusively evidenced by the
42 execution thereof by the County Executive.

46 This Resolution is hereby declared an emergency in the interest of the health, safety and
47 welfare of the residents of the County of Summit, and for the further reason to immediately
48 allow the City of Akron to use the indoor and outdoor firing ranges at the County of Summit
49 Sheriff Robert D. Campbell Training Facility in 2019.


