7 **A Resolution authorizing the County Executive to execute any documents necessary to**
8 **accept an award from the Ohio Department of Public Safety’s Office of Criminal Justice**
9 **Services of an Edward Byrne Memorial Justice Assistance grant, for the period 7/1/19**
10 **through 6/30/20, in the amount of \$47,753.79, with no local cash match required, and**
11 **appropriating funds, for the Court of Common Pleas-General Division, and declaring an**
12 **emergency.**

14 WHEREAS, the Ohio Department of Public Safety’s Office of Criminal Justice Services
15 (“ODPS-OCJS”) has awarded the Court of Common Pleas-General Division an Edward Byrne
16 Memorial Justice Assistance grant, for the period 7/1/19 through 6/30/20, in the amount of
17 \$47,753.79, with no local cash match required; and

19 WHEREAS, this Edward Byrne Memorial Justice Assistance grant will fund the salary
20 and benefits for a full-time Valor Court Community Development Director; and

22 WHEREAS, it is necessary to appropriate said grant funds; and

24 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
25 that it is necessary and in the best interest of the County of Summit to authorize the County
26 Executive to execute any documents necessary to accept the award of the aforementioned
27 Edward Byrne Memorial Justice Assistance grant from the ODPS-OCJS, and to appropriate said
28 grant funds;

21 salary and benefits of the full-time Valor Court Community Development Director.


