7 **A Resolution confirming an award by the Board of Control of a construction contract with**  
8 **Pavement Technology, Inc. for the 2020 Summit County Regional Asphalt Rejuvenating**  
9 **Program, in an amount not to exceed \$152,950.00, for the Engineer, and declaring an**  
10 **emergency.**

11  
12 WHEREAS, this Council previously adopted Resolution No. 2019-452, which authorized  
13 the County Executive to advertise as needed for bridge engineering and construction projects,  
14 and pavement maintenance projects, for the Engineer’s 2020 Capital Improvements Program, for  
15 an estimated total cost not to exceed \$5,290,750.00; and

16  
17 WHEREAS, following the receipt and review of bids, the County Executive proposes  
18 entering into a construction contract with Pavement Technology, Inc. for the 2020 Summit  
19 County Regional Asphalt Rejuvenating Program, in an amount not to exceed \$152,950.00; and

20  
21 WHEREAS, the proposed work consists of furnishing all labor, equipment. and material,  
22 and performing all operations necessary for the rejuvenation and in depth sealing of asphaltic-  
23 concrete surface courses by spray application of a cationic rejuvenating agent composed of  
24 petroleum oils and resins emulsified with water in accordance with the specifications and terms  
25 of the contract; and

27 WHEREAS, the contract total will be broken down by political subdivision as follows  
28 with each subdivision responsible for directly paying Pavement Technology, Inc.:

30 County: \$107,465.20  
31 Twinsburg Twp: \$45,484.80

33 WHEREAS, the Board of Control, at its meeting held May 6, 2020, awarded a  
34 construction contract with Pavement Technology, Inc. for the 2020 Summit County Regional  
35 Asphalt Rejuvenating Program, in an amount not to exceed \$152,950.00, subject to confirmation  
36 by County Council; and

37  
38 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
39 that aforementioned construction contract with Pavement Technology, Inc. is necessary and in  
40 the best interest of the County of Summit;

42 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
43 of Ohio, that;

47 The award by the Board of Control of a construction contract with Pavement Technology,  
48 Inc. for the 2020 Summit County Regional Asphalt Rejuvenating Program, in an amount not to  
49 exceed \$152,950.00, is hereby confirmed and the County Executive is hereby authorized to  
50 execute such construction contract and any other necessary related documents.
