WHEREAS, sanitary sewer easements are needed for the Stow Gorge Sewer Replacement Project (Q-323-1) ("Project"), located in the City of Stow, in Council District 3; and

WHEREAS, the County Executive desires to execute an agreement with RLM Darrow Road, LLC, in the amount of \$2,200.00, to acquire an easement over the real property located at 2423 Darrow Road, Stow, Ohio 44224 and known as Permanent Parcel Number 5619466, as part of the Project; and
