The County Executive is hereby authorized to execute amendments to the Five-Year Consolidated Plan for 2015-2019 ("Consolidated Plan"), the 2019 Action Plan ("Action Plan") and the Citizen Participation Plan for Community Development Block Grant ("CDBG") Program and Home Investment Partnership Program ("HOME") and to execute any other additional required documents, in order for the County of Summit to receive additional federal funding, in the amount of \$567,622.00, from the U.S, Department of Housing and Urban Development ("HUD").

SECTION 3
