7 **A Resolution approving the assignment to The Computer Solution Company of Virginia,**  
8 **LLC of a professional service contract with ThincIT LLC for the purchase of the Forensic**  
9 **Advantage Medical Examiner System, in an amount not to exceed \$131,860.00 for the**  
10 **System and one year of maintenance, in an amount not to exceed \$54,560.00 for four**  
11 **additional years of maintenance, for a total amount not to exceed \$186,420.00, and**  
12 **authorizing the County Executive to execute a consent to assignment and any other**  
13 **necessary documents to approve said assignment of the contract, for the Office of**  
14 **Information Technology, and declaring an emergency.**

16 WHEREAS, County Council previously adopted Resolution No. 2018-116, which  
17 confirmed the award by the Board of Control of a professional service contract with ThincIT  
18 LLC for the purchase of the Forensic Advantage Medical Examiner System, in an amount not to  
19 exceed \$131,860.00 for the System and one year of maintenance, in an amount not to exceed  
20 \$54,560.00 for four additional years of maintenance, for a total amount not to exceed  
21 \$186,420.00; and

23 WHEREAS, ThincIT LLC has requested that the County authorize the assignment of the  
24 aforementioned professional service contract to The Computer Solution Company of Virginia,  
25 LLC ("TCSC"); and

27 WHEREAS, it is necessary for this Council to approve the assignment by ThincIT LLC  
28 of the professional service contract to TCSC and to authorize the County Executive to execute a  
29 consent to assignment and any other necessary documents to approve said assignment of the  
30 contract to TCSC; and; and

32 WHEREAS, this Council finds and determines, after reviewing all pertinent information,  
33 it is necessary and in the best interest of the County of Summit to approve the assignment by  
34 ThincIT LLC of the professional service contract to TCSC and to authorize the Executive to  
35 execute a consent to assignment and any other necessary documents to approve said assignment  
36 of the contract to TCSC;

38 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

43 The assignment by ThincIT LLC of the professional service contract to The Computer  
44 Solution Company of Virginia, LLC ("TCSC"), for the purchase of the Forensic Advantage  
45 Medical Examiner System, in an amount not to exceed \$131,860.00 for the System and one year  
46 of maintenance, in an amount not to exceed \$54,560.00 for four additional years of maintenance,  
47 for a total amount not to exceed \$186,420.00, is hereby approved. The County Executive is  
48 hereby authorized to execute a consent to assignment and any other necessary documents to  
49 approve said assignment of the contract.

9 LLC so that TCSC can immediately continue to provide necessary maintenance services for the  
10 Forensic Advantage Medical Examiner System.

15 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
16 effect and be in force at the earliest time provided by law.
