A Resolution authorizing the County Executive to execute agreements for the acquisition of drainage easements at 650 and 694 North Cleveland-Massillon Road, located in Bath Township, in Council District 5, for a total amount not to exceed \$744.00, as part of the Cleveland-Massillon Road and Ghent Road Intersection Improvement Project, for the Engineer, and declaring an emergency.

WHEREAS, there is a public need to improve drainage at the intersection of North Cleveland-Massillon Road and Ghent Road, including replacing a culvert with an 18 inch storm sewer and installing a headwall with rock channel protection as part of the Cleveland-Massillon Road and Ghent Road Intersection Improvement Project, located in Bath Township, in Council District 5 (the "Project"); and

WHEREAS, certain land must be acquired by the County to be utilized as a public right-of-way as part of the Project; and

WHEREAS, acquisition of land for a public right-of-way for the Project is considered a local cost, which must be borne in whole by the local public agency performing the Project; and

WHEREAS, the County has negotiated terms for agreements for the acquisition of standard highway easements at 650 and 694 North Cleveland Massillon Road in Bath Township, Council District 5 to serve as the necessary public right-of-way for the Project, in a total amount not to exceed \$744.00; and

WHEREAS, this Council has determined, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute the aforementioned agreements for the acquisition of standard highway easements;
