A Resolution authorizing the County Executive to execute a grant agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health, for a grant, in an amount not to exceed \$180,000.00, to operate a needle exchange program from 4/1/20 through 3/31/21, for the Executive, and declaring an emergency.

WHEREAS, pursuant to Resolution Nos. 2019-332 and 2019-361, County Council authorized the County Executive to settle any or all claims, and to execute any corresponding settlement agreements, in litigation titled In re: National Prescription Opiate Litigation, Case No. 1:17-MD-2804, before Judge Dan Aaron Polster in the United States District Court, Northern District of Ohio (the "Lawsuit"), with any manufacturing or distributor Defendant, regardless of market share of the opioid market in Summit County and to additionally authorize settlement with any pharmacy Defendants; and

WHEREAS, the County has received monies as a result of settlement of the Lawsuit; and

WHEREAS, the experts in the Lawsuit determined that the County and its communities have four main areas of concern: (1) Treatment; (2) Harm Reduction; (3) System Coordination; and (4) Education/Prevention; and

WHEREAS, the County Executive has convened a Key Stakeholders Group to oversee expenditure of settlement funds in these four areas; and

WHEREAS, the Key Stakeholders have recommended to County Council that it authorize a grant from the settlement funds, in an amount not to exceed \$180,000.00, to the Summit County Combined General Health District d.b.a. Summit County Public Health to operate a needle exchange program from 4/1/20 through 3/31/21; and

WHEREAS, this Council finds and determines, after reviewing all pertinent information, that it is necessary and in the best interest of the County of Summit to authorize the County Executive to execute a grant agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health, for the aforementioned grant, in an amount not to exceed \$180,000.00;

NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State of Ohio, that:

SECTION 1

The County Executive is hereby authorized to execute a grant agreement with the Summit County Combined General Health District d.b.a. Summit County Public Health, for a grant, in an amount not to exceed \$180,000.00, to operate a needle exchange program from 4/1/20 through 3/31/21.
