WHEREAS, this Council finds and determines, after reviewing all pertinent information, that aforementioned construction contract with Melway Paving Co., Inc. is necessary and in the best interest of the County of Summit.;

SECTION 1

The award by the Board of Control of a construction contract with Melway Paving Co. Inc., for the 2020 Summit County 405 Resurfacing Program, in an amount not to exceed \$1,738,852.05, is hereby confirmed and the County Executive is hereby authorized to execute such construction contract and any other necessary related documents.

SECTION 2

This Resolution is hereby declared an emergency in the interest of the health, safety and welfare of the residents of the County of Summit, and for the further purpose to immediately provide a necessary construction contract for the 2020 Summit County 405 Resurfacing Program.

SECTION 3

Provided this Resolution receives the affirmative vote of eight members, it shall take effect immediately upon its adoption and approval by the Executive; otherwise, it shall take effect and be in force at the earliest time provided by law.
