7 **A Resolution authorizing the Sheriff and Fiscal Officer to pay 2020 uniform stipends and**  
8 **vouchers in the amount of, and in the manner provided under Article 27 of the collective**  
9 **bargaining agreement with the Fraternal Order of Police (Deputies' Unit) for the year**  
10 **2019, which is \$1,700.00 for each uniformed bargaining unit employee under that**  
11 **agreement, for the Sheriff and the Executive, and declaring an emergency.**

13 WHEREAS, the collective bargaining agreement with the Fraternal Order of Police  
14 (Sheriff's Deputies) that expired on December 31, 2019 is currently being negotiated for a new  
15 three year term, and those negotiations have been temporarily interrupted due to the current  
16 COVID-19 crisis and related restrictions; and

18 WHEREAS, it is of vital importance during the pendency of said crisis, that those  
19 uniformed bargaining employees be able to acquire and maintain the proper uniforms and  
20 equipment;

22 WHEREAS, this Council finds it in the best interests of the County, and in the interest of  
23 the health and safety of its uniformed officers and the public, to authorize the payment of uniform  
24 stipends and vouchers for 2020 in the amount of, and in the manner provided under Article 27 of  
25 the collective bargaining agreement with the Fraternal Order of Police (Deputies' Unit) for the  
26 year 2019, which is \$1,700.00 for each uniformed bargaining unit employee, immediately;

28 NOW, THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State  
29 of Ohio, that;

31 SECTION 1

33 The Sheriff and the Fiscal Officer are hereby authorized to pay 2020 uniform stipends  
34 and vouchers in the amount of, and in the manner provided under Article 27 of the collective  
35 bargaining agreement with the Fraternal Order of Police (Deputies' Unit) for the year 2019,  
36 which is \$1,700.00 for each uniformed bargaining unit employee, immediately.

38 SECTION 2

40 This Resolution is declared an emergency in the interest of the health, safety, and welfare  
41 of the residents of the County of Summit, and for the further reason that it immediately enables  
42 uniformed bargaining employees to acquire and maintain the proper uniforms and equipment.

46 Provided this Resolution receives the affirmative vote of eight members, it shall take  
47 effect immediately upon its adoption and approval by the Executive; otherwise, it shall take  
48 effect and be in force at the earliest time provided by law.


