7 **A Resolution confirming an award by the Board of Control of a renewal (second and final),**
8 **of a professional service contract with Oriana House, Inc. to provide treatment and**
9 **program services under the Fiscal Year 2017 Multi-Jurisdictional Drug Court program for**
10 **the project period of 9/30/19 through 9/29/20, in an amount not to exceed \$323,700.00, for**
11 **the Executive’s Department of Law and Risk Management–Division of Public Safety and**
12 **declaring an emergency.**

14 WHEREAS, the Board of Control, at its meeting held April 8, 2020, awarded a renewal
15 (second and final), of a professional service contract with Oriana House, Inc. to provide
16 treatment and program services under the Fiscal Year 2017 Multi-Jurisdictional Drug Court
17 program for the project period of 9/30/19 through 9/29/20, in an amount not to exceed
18 \$323,700.00, subject to confirmation by County Council; and

20 WHEREAS, the Substance Abuse and Mental Health Administration (“SAMHSA”) has
21 awarded grant funds for a third project period, of three, for the Fiscal Year 2017 Multi-
22 Jurisdictional Drug Court program, from 9/30/19 through 9/29/20; and

24 WHEREAS, County Council previously adopted Resolutions No. 2017-406 and 2018-
25 385, which authorize the Executive to execute agreements with Oriana House, Inc. to provide
26 treatment and services for the Multi-Jurisdictional Drug Court program for the project periods
27 9/30/17 through 9/29/18 and 9/30/18 through 9/29/2019, respectively; and

29 WHEREAS, this Council finds and determines, after reviewing all pertinent information,
30 that the aforementioned renewal (second and final) of a professional service contract with Oriana
31 House, Inc. is necessary and in the best interest of the County of Summit;

33 NOW THEREFORE, BE IT RESOLVED by the Council of the County of Summit, State

42 Executive is hereby authorized to execute such professional service contract.
